Fee is \$ 20.00 per season; non refundable. Please complete this application and make a check out to Brookfield Lions Community Garden. Mail both to Brookfield Parks & Recreation PO Box 5106 c/o Lions Community Garden, Brookfield, Ct. 06804. There are 35 Garden Plots. Applications will be time stamped and plot assignments will be on a first come basis until there are no more plots. A waiting list, if necessary, will be developed based on receipt of the applications, time stamp and in case of cancellations this list will be used to fill vacancies. You will receive a copy of your application, notifying you of your plot assignment or position on the waiting list. Refilling each year is not necessary. The plot assignment is yours until you cancel or the contract is terminated because of non-compliance with the Brookfield Lions Community Garden Guidelines. We will also maintain the waiting list and add names to said list as we receive them, maintaining our time stamp philosophy.

General Garden Guidelines 2009

The garden plot (8'by 14') must be maintained, planted or mulched. Paths are to be at least 4 feet wide and not mulched. Plot edges will be marked with stakes; there can be no raised beds. Please do not go beyond the boundaries of your plot. Plants that are beyond the stakes will be removed at the discretion of the Garden Captain (Tony Licursi 775-2748). No vine plants are to be planted IE. Cucumbers, pumpkins, squash unless they are of the bush variety. Harvest and weed your plot in a timely manner. Gardeners who have consistently weedy, unsightly plots will be notified and asked to clean up their assigned plot/pathway within 10 days. Contact Garden Captain if you have questions. Failure to tend to your plot after being notified will classify the plot as abandoned and the plot will be reassigned. If you are going to be out of town on extended leave, please notify the Garden Captain that you will be gone and that the plot will be taken care of as soon as you return.

Garden tools will be available; it is up to the gardener to clean them after each use and return them to the tool shed. If you have some tools that you would like to donate; they will be welcome.

Please do not remove trees, shrubs, alter or plant outside your designated garden area. Exceptions to this are only with written approval from the Garden Captain or representative from Brookfield Lions Community Garden Executive Board.

Plots can be started by April 10 and no later than June 1st . Gardeners are encouraged to weed and plant earlier, as weather permits. Plot fees and deposits are not refundable if there is a cancellation or there is a non-compliance with garden guidelines. The fee is \$20.00

Plots are non transferable. Registered gardeners are responsible for keeping addresses and phone numbers current with the community gardens program and Garden Captain. Failure to be able to notify you after three unsuccessful attempts (number disconnected, etc.) will result in the plot being reassigned due to abandonment of the plot.

Dogs must be leashed and not allowed to go into the garden. People must use the paths without going through other gardener's plots. Harvest only from your assigned plot.

Water only within your assigned plot. Do not let water drip or flood other plots or the paths. Conserve water by hand watering and by using mulch. Be courteous to other gardeners.

Organic gardening is encouraged; there are many earth friendly products. Please do not use herbicides (weed killers) in the garden areas. Please contact the Garden Captain if you have questions on what is approved for use. A list of appropriate chemicals will be posted on the Garden Captain's Bulletin Board in the tool shed.

Crops are for home use, not commercial purpose, and must be legal. Do not allow plants to shade other gardens or grow into the pathways.

Gardens must be cleaned, cover cropped or mulched by October 15th. Those not cleared may lose plot registration for the following year.

Gardeners must abide by these guidelines to qualify for a plot in the community gardens program. Check with your Garden Captain for any specific question not covered in these guidelines.

The same plot will be assigned to you if you choose to participate the following year. Have fun growing your own vegetables, flowers and fruits!
