Town Budget Process: The Town's budget process for 2016 - 2017 is underway. The First Selectman will review and evaluate department head requests in early February. In mid-February, the Board of Selectmen will begin their deliberations on the First Selectman's recommended budget. The Board of Education will make their presentation to the Board of Selectmen and the Board of Finance on Tuesday, February 2 at 7:00pm in Meeting Room 133. The Board of Selectmen will submit its budget recommendations at the end of February to the Board of Finance. The Board of Finance will then review the budget throughout the month of March. TAX COLLECTOR NOTICE

LAST DAY TO PAY WITHOUT PENALTY **FEBRUARY 1, 2016**

Payment must be RECEIVED or U.S. POSTMARKED by February 1, 2016 for the Supplemental Motor Vehicle taxes and the second installment of the Real Estate and Personal Property taxes. If taxes are unpaid by that date, the interest penalty in February will be 3% with a \$2 minimum. Failure to receive a tax bill does not invalidate the tax or interest.

You can make payments online at our website, www.brookfieldct.gov. Go to the Departments link, choose Tax Collector and click on link "Pay Taxes/Tax Inquiry". Follow the prompts to make your payment. Please note there are fees for this service. Payments accepted online are credit cards and echeck. To pay in the office, cash or check only, our collection hours are Monday, Tuesday, Wednesday, Friday 8am-4pm and Thursday 8-6pm.

ELDERLY BENEFIT REQUIREMENTS FOR 2015 GRAND LIST 2016/2017 TAX BILL

TOWN-ELDERLY

- 1. Such person or spouse is 65 years of age or older by December 31 of the prior year.
- 2. Such person has resided and paid real estate taxes on their residence located in Brookfield for a period of five years immediately prior to application for tax credit. Applicant must be current on their tax payments.
- 3. The net assessment of such property shall not exceed the median assessment of \$240,180 for the current 2015 Grand List year.
- 4. Property must be the legal residence of such person, occupied more than 183 days of each calendar year.
- 5. Income must not exceed \$49,280 for unmarried people and \$60,060 for married people. "Income" is defined as total income from 1040 PLUS Social Security and tax exempt income. If not filing income tax, copies of all statements.
- 6. Applicant must be record owner of property as of October 1st.
- Applications must be filed between Feb 1st and May 15th annually.
 Note: May 15th falls on a Sunday this year, therefore all applications must be in the Assessor's Office by Friday May 13th, 2016

TOWN-VETERANS

- 1. Must have DD214 filed with the Town Clerk's Office by September 30th of the Grand List year in which you are applying.
- 2. Must have served during an eligible war period and have been Honorably Discharged.
- 3. Income must not exceed \$52,700 for unmarried people and \$58,900 for married people. "Income" is defined as total income from 1040 PLUS Social Security and tax exempt income.
- 4. Filing period is from February 1st to September 30th.

STATE ELDERLY AND STATE VETERANS

- 1. Owner of Real Property as of October 1st of filing year, legal residence and age 65 as of December 31st of the prior year.
- 2. Income cannot exceed \$35,200 for unmarried people and \$42,900 for married people. "Income" is defined as total income from 1040 PLUS Social Security and tax exempt income. If not filing income tax, copies of all statements are required.

Public Works News

Updated road ratings have been posted to the town website. Our paving budget and schedule are being prepared. When the town budget is approved the road paving list will be updated.

Land Use News

The Zoning Commission public hearing for 763-777 Federal Road, The Renaissance Affordable Housing Project, is continued to February 11, 2016. The Inland Wetlands public hearing for this project is continued to February 8, 2016.

Brookfield Conservation Commission

The Brookfield Conservation Commission is working in conjunction with the CT State Historic Preservation Office to preserve the buildings at the Gurski Homestead on Obtuse Hill Road. The Gurski Homestead Committee, which oversaw the property from 2004 - 2012, received several grants with easement restrictions from CT State Historic Preservation Office (SHPO). This means that work must be done to preserve the structures and all work must meet the guidelines of SHPO. During the past few weeks, the drainage for the property, particularly the front farmhouse, has been corrected, thanks to the help of the Brookfield Public Works. Work over the next few months will include working on a master plan for the property, and holding public meetings or a survey to get public comment.

Social Services News

CT Energy Assistance Program (CEAP) benefits have been announced for this heating season. Contingency Heating Assistance Program (CHAP) benefits are also available this year for higher income households. Here are the maximum income guidelines for these programs:

Household Size: 1 2 3 4 5 6

Annual income: \$33,132 \$43,327 \$53,521 \$63,716 \$73,910 \$84,105

Households with liquid assets exceeding \$15,000 for homeowners, and \$12,000 for all other households may still be eligible for energy assistance benefits if the annual gross income, combined with the amount of liquid assets over the limit, is within the income guidelines. Benefits are determined using current annual income for all adults in the household. Benefits are higher for lower income households. This program is designed to assist with heating expenses and will not usually cover all heating costs for the season. Call Brookfield Social Services now for an appointment if you heat with oil or propane.

Health Department News

Brookfield residents have expressed concerns about the newest threat to their overall health. There has been much publicity in recent weeks surrounding the so-called Zika virus outbreak in South America. With the upcoming Olympics in Brazil this summer, the issue is of increasing concern. Fortunately, we here in the north are in the midst of our winter, when mosquitoes, the carrier of the virus, are non-existent. Symptoms of the disease include fever, rash, joint pain and redness of the eyes. The illness is usually mild and lasts from a few days to a week. Pregnant women are singled out, not because of more intense illness, but because of the possible connection between birth defects such as microcephaly (small head size) and the disease. The Centers for Disease Control is advising pregnant women to postpone travelling to 28 countries and territories where mosquitoes are transmitting the virus. Twenty-five are in Latin America and the Caribbean. The other three are Cape Verde off the coast of Africa and Samoa and American Samoa in Polynesia. Cases of microcephaly and other neurologic birth defects have followed recent Zika outbreaks in French Polynesia, according to World Health Organization.

So far, Zika is not considered endemic in the United States and there is little cause for worry. The only cases reported here involve people who have recently visited areas subject to the CDC's travel warning. The CDC expects that mosquitoes will eventually transmit the virus in the United States. The mosquito involved, however, is not the same type which transmits Lyme disease. However, the CDC has said that it anticipates smaller outbreaks than those seen in Latin America, given less densely populated urban areas, greater use of air conditioning, and more widespread mosquito control measures in the United States. 
