#### 2016/2017 CAPITAL BUDGET REFERENDUM

The date of the 2016/2017 Capital Budget Referendum is Tuesday, July 19, from the hours of 6:00am through 8:00pm. District 1 voters will vote at Huckleberry Hill School and District 2 voters will vote at Brookfield High School. The appropriation of \$2,835,000 will fund the costs of the Town and School improvements comprising a portion of the Town's Capital Improvement Program for Fiscal Year 2016/2017. from the Pennysaver will arrive at your home the Thursday before the Referendum. Please mark your calendar and remember to vote!

#### BOARD OF SELECTMEN SPECIAL TOWN MEETING

The Board of Selectmen has scheduled a Special Town Meeting prior to the regular BOS meeting on July 11 at 7:00pm in Meeting Room 133 regarding an appropriation of \$500,000 to be totally funded (100%) from the DECD STEAP Grant in addition to funds previously appropriated for said project. The Special Town Meeting notice and attachments are filed at the Town Clerk's Office and on the Town's <u>website</u> under News and Announcements and/or legal notices.

#### CONNECTICUT SITING COUNCIL PUBLIC HEARING

The Connecticut Siting Council (CSC) has scheduled a Public Hearing at Town Hall on August 2 at 7:00pm (public comment session) in Meeting Room 133 on Homeland's proposed 150' tall facility to be located behind the firehouse. The hearing will be on an application from Homeland Tower, LLC and Cellco Partnership d/b/a Verizon Wireless for a Certificate of Environmental Compatibility and Public Need for the construction, maintenance, and operation of a telecommunications facility proposed to be located at 100 Pocono Road. Verizon is a co-applicant on this project. Homeland Towers will be floating a balloon at the proposed tower site that day from 8:00am - 6:00pm, weather permitting. We will also conduct a field visit at the site with CSC members at 2:00pm so they may have the opportunity to visit the site first hand and ask our engineer/consultants any questions.

# **Tax Collector News**

The first installment of Real Estate and Personal Property taxes due on the Grand List of 2015 is due and payable as of July 1, 2016. All motor vehicle taxes are also due. If you believe your Motor Vehicle bill is incorrect, please contact the Assessor's office at (203)775-7302 or visit their <u>website</u> page for more information.

Taxes not paid by August 1, 2016 will become delinquent and interest will be charged from the due date of July 1, 2016 at the rate of 1 1/2% per month - minimum interest charged is \$2.00. Failure to receive a bill does not exempt you from the tax or the penalty. There is a \$20.00 service charge for all returned checks.

Visit the Town of Brookfield <u>website</u> to pay online by either Credit Card (MasterCard, Visa, or Discover are accepted) or ECheck. A convenience fee is charged for this service. You may also view your tax bills online at <u>www.brookfieldct.gov</u>

A self-addressed, stamped envelope must be enclosed if you wish a receipt. Taxes

are payable at Brookfield Town Hall, 100 Pocono Road or by mail addressed to TAX COLLECTOR, P.O. BOX 508, BROOKFIELD, CT 06804-0508.

Payments made by electronic checks from your bank account are sometimes delayed. The money will be removed from the account for processing but the bank may not get the check in the mail as you have requested. If the payment is received after the grace period, the Tax Collector must look at the post mark to determine if the payment is to be considered on time. If there is no post mark then the Tax Collector must consider the payment as late. CT State Statute 12-146 clearly states, "No tax or installment therefor shall be construed to be delinquent under the provision of this section if the envelope containing the amount due as such tax is payable, bears a postmark showing a date within the time allowed by state statute for the payment of such tax or installment" The law does not refer to check dates or banking records so US Postmark is the only legal writing tax collectors can accept. If you need to make payment this way, please give the bank plenty of time for processing. Also make sure the tax bill information is clearly written on the check so that we credit the correct account.

#### TOWN OF BROOKFIELD NOTICE OF REFERENDUM

The legal voters of the Town of Brookfield and those entitled to vote therein, are hereby warned and notified that a referendum will be held on July 19, 2016, between the hours of 6:00am and 8:00pm, to vote on the following question: "SHALL THE TOWN APPROPRIATE \$2,835,000 TO FUND THE COSTS OF THE 2016-17 CAPITAL IMPROVEMENTS PROJECT AND AUTHORIZE BONDS OR NOTES AND TEMPORARY NOTES OF THE TOWN IN AN AMOUNT NOT TO EXCEED \$2,835,000 TO FINANCE THE APPROPRIATION?"

District 1 voters will vote at Huckleberry Hill School. District 2 voters will vote at Brookfield High School.

In addition, property owners, 18 years of age and a United States Citizen, with an assessment of not less than \$1,000.00, pursuant to the property tax assessment provisions of Section 7-6 of the Connecticut General Statutes, shall vote at Brookfield High School.

Absentee Ballots will be available from the Town Clerk's Office on June 28, 2016. Copies of the Explanatory Text are available in the office of the Town Clerk. Voting machines shall be used.

Absentee Ballots will be counted at the Brookfield Town Hall.

# **Blue-Green Algae Concern on Brookfield's Lakes**

The recent bout of very warm weather and the lack of rain have resulted in an early bloom of Blue-Green algae on Brookfield's lakes. This has caused considerable concern, particularly among lake shore residents and those seeking relief from the heat at public beaches.

There has been increasing news each summer about these algae blooms and the closing of some popular beaches in Connecticut due to the fact that some of these algae produce harmful substances called "cytotoxins." Perhaps the most widely known of these algae blooms is the so-called "Red Tide" found off of Southern beaches in Spring and early Summer.

The Blue-Green algae blooms, which have been found on Lake Candlewood and Lake Zoar, appear as a green or blue-green scum on the surface of the water and may extend several feet below the surface. The algae clings to boats, docks, rocks and the shoreline. ONLY A SMALL PERCENTAGE of Blue-green algae actually produce harmful substances or "toxins." These Cytotoxins may produce skin irritation on contact or, if released into the air by boat propellers, water skiers or the wind, may cause lung irritation and breathing difficulties. They may also cause abdominal problems if taken in orally.

The appearance of these blooms is dependent on heat, humidity, stagnation and the concentration of nutrients such as Nitrates and Phosphates, which are the direct result of human habitation. Nitrates leech into the soil from septic systems, while phosphates result from lawn and yard runoff, as the result of expanding fertilizer use.

Along with the production of Nitrates, potentially harmful fecal bacteria such as E. coli may leech into the soils from septic systems, particularly failed or failing systems. The Brookfield Health Department has been working arduously to reduce the number of such failing systems, particularly along the shoreline of our beautiful lakes and rivers. Rigorous adherence to the State Sub-surface Septic System regulations is not only a benefit, but an absolute necessity, to preserving the health of Brookfield residents and visitors.

The Candlewood Lake Authority has willingly accepted the daunting task of testing for Blue-green algae toxins and for harmful E. coli bacteria. With 60-plus small shoreline communities on Candlewood alone, their efforts (and finances) are spread thin. E. coli testing will continue to be done weekly at the Town Beach (Cadigan Park) and at the Candlewood Shores beach. Testing for Blue-green algae toxins is much more expensive and will be carried out at the Town Beach. Other private shoreline communities should consult their association leadership about individual location testing. Despite the widespread presence of Blue-green algae on Candlewood Lake in June, testing has revealed an extremely LOW to NO level of harmful toxins in these blooms. The Public will be kept informed of any significant concerns and Beach closures may take place if the levels of toxins in the algae reach a potentially harmful level.

# **Brookfield Conservation Commission**

The Brookfield Conservation Commission held a CT Trail Day event on June 4, 2016. It was a letterboxing and Arbor Day event at the Gurski Homestead and Williams

Park that was well attended.

Brookfield Conservation Commission has received a \$10,000 matching grant from the CT Trust for Historic Preservation to create a Master Plan for the Gurski Homestead. This will include surveys and/or meetings to gather input from residents.
