STREAMLINING THE INSPECTION PROCESS

Our Building team has created a telephone number you can call to get the inspection schedule. You can now call 203-775-7325 after 4pm the day before your inspection. You just listen for

your address and we give you a one hour inspection window that we will be there. This has been working very well for everyone and has eliminated up to 10 to 20 phone calls a day from property owners trying to find information on their inspection times. Shortly, we plan on putting information on the town website showing inspection schedules. Doing this saves time and money for both the property owners and the town.

DEVELOPMENT IN THE FOUR CORNERS

If you have driven by the Four Corners, you can see the Brookfield Village Development going up. The first two buildings are scheduled to be completed by fall of this year. We welcome Brookfield Village to our town and look forward to working with them.

REFERENDUM ON STREETSCAPE

We recently held a referendum to fund Phase I of the Streetscape in the Four Corners. We are pleased to announce that it was approved by an almost 2 to 1 margin. This project, which is funded almost 60% with grants, will bring sidewalks, streetlamps and other amenities to start our beautiful new downtown district. In turn we hope that this investment will bring great developers who will continue to enhance our downtown with quality building that meets our town's desire to have a New England style town center. That in turn will generate more tax revenues for the town as we continue to improve Brookfield.

ZONING MORATORIUM

We are hiring a lawyer who is an expert to guide us through the process of applying for a moratorium on the 8-30 G housing that allows developers to ignore virtually all of our zoning laws and build any housing they want, as long as it complies with the State's 8-30-G law. Brookfield supports and wants a wide variety of housing types with rent ranges to make it affordable for all. However, we do not support having virtually no control over

what gets built. This moratorium will block the ability of developers from using 8-30-G to override our zoning for a period of four years.

ZONING REWRITE

We have hired the firm of Milone and McBroome to assist the town in a complete update and re-writing of all of our zoning laws. We have already held planning meetings with them. This firm has done high quality work for the town in the past and they know our town very well. Over the next few months we will be holding public meetings to get your input on what changes might be needed to our laws. Please do come out and share your thoughts.

BOARD OF SELECTMEN MEETING

The next regular Board of Selectmen Meeting will be held on Monday, March 6, at 7:30 pm at Brookfield Town Hall. BOS PUBLIC HEARING - 2017 COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM Prior to the Board of Selectmen Meeting on Monday, March 6, the Selectmen have scheduled a Public Hearing from 7:00 - 7:30 pm. The purpose of the public hearing is to obtain resident's views on the Town's community development and housing needs and to review and discuss specific project activities in the areas of housing, economic development or community facilities. These projects could be part of the Town's Application for a grant amount of \$400,000 under the housing rehabilitation category for interest free - deferred payment home improvement loans for qualified low and moderate income residents. The hearing will also review and discuss the Town's prior Small Cities projects including any currently open or underway.

TOWN BUDGET PROCESS IN THE MONTH OF MARCH

The Town's budget process for 2017 - 2018 is underway. The First Selectman reviewed and evaluated department head requests in early February. In mid-February, the Board of Selectmen began their deliberations on the First Selectman's recommended budget. The First Selectman's budget message and budget proposal can be viewed on the Town's website under News & Announcements. The Board of Selectmen will finalize their budget to forward to the Board of Finance the first week of March.

Tax Collector News

Tax Information 2016 - Tax Report: If you need your 2016 Tax Payment information go to this link: http://www.brookfieldct.gov/Pages/BrookfieldCT_Tax/index. Click on the View or Pay Tax Bills button. Click on For All Online Payments and Payment History. Enter your last name and first initial. (NO punctuation) or you may change the "search by" to whatever you wish. Next click on IRS Payment Records for Year 2016 and then click on Search.

This will bring up the payment records for 2016. Place a check mark in the IRS box located on the right side above the payment information on the blue/green bar and then click on View IRS. This will show the amount of the payment and the date the payment was made. You can print out this information for your records.

Real Estate Bill

If your Real Estate taxes are escrowed, the bank should request your Real Estate bill. If you change banks or pay off your mortgage, please contact the office to let us know where your Real Estate bill should be sent.

Tax Assessor News

Town Elderly Tax Relief Benefit requirements for the 2016 GRAND LIST (2017/2018 tax bills) are as follows:

1. An applicant or their spouse was 65 years of age or older as of December 31, 2016.

- 2. A person has resided and paid real estate taxes on their residence located in Brookfield for a period of five years immediately prior to application for tax credit. Applicants must be current on their tax payments.
- 3. The net assessment of an applicant's property shall not exceed the median assessment of \$236,860 for the current 2016 Grand List year.
- 4. A property must be the legal residence of an applicant and occupied by the applicant more than 183 days of each calendar year.
- 5. Applicant income must not exceed \$49,280 unmarried and \$60,060 married. "Income" is defined as total income from the 2016 IRS Form 1040 PLUS Social Security and tax exempt income. If an applicant is not filing an income tax return, copies of all income statements for 2016 must be submitted with an application.
- 6. Applicant must be the record owner of a property as of October 1, 2016.
- 7. Applications must be filed between Feb 1st and May 15th annually.

Town Additional Veteran Exemption requirements for the 2017 GRAND LIST (2018/2019 tax bills) are as follows:

- 1. Must have form DD214 Discharge filed with the Town Clerk's Office by September 30th of the Grand List year in which a veteran is applying.
- 2. Veteran must have served during an eligible war period and have been Honorably Discharged.
- 3. Income must not exceed \$52,700 unmarried and \$58,900 married for the calendar year 2016. "Income" is defined as total income from the 2016 IRS form 1040 PLUS Social Security and tax exempt income.
- 4. Filing period is from February 1 to September 30.

State Elderly Tax Relief Benefit and State Additional Veteran Exemption requirements are as follows:

- 1. Applicants must be the owners and legal residents of Real Property as of October 1st of the filing year. Elderly Tax Relief applicants or their spouse had to be age 65 as of December 31, 2016. There is no age limit for the State Additional Veteran Exemption.
- 2. Income cannot exceed \$35,200 unmarried and \$42,900 married. "Income" is defined as total income from the 2016 IRS form 1040 PLUS Social Security and tax exempt income. If an applicant is not filing an income tax return, copies of all income statements for 2016 must be submitted with an application.

Social Services News

Rebuilding Together of Litchfield County (and surrounding towns) rehabilitates the homes of our older residents with limited resources who are living in unsafe and sub-standard conditions. Skilled and lay volunteers work with the homeowners to complete necessary repairs to keep the homeowners safe and comfortable. Once a year Rebuilding Together hosts a Re-Build Day, a large-scale event to repair about 25 homes in Litchfield County and the surrounding area. This year the Annual Rebuild Day will be held on on April 29th. They will need lots of volunteers, so whether or not you are a professional builder, carpenter, plumber, electrician, etc., you are needed! It is also a lot of fun! Volunteers will meet at 7:45 am at Education w/o Walls, 64 Railroad Street, New Milford, for coffee, juice and doughnuts. No need to sign up beforehand - just show up! Zoning Regulation Rewrite

The Zoning Regulation Rewrite Ad Hoc Committee, including representatives of the Board



of Selectmen, Planning & Zoning Commissions, Zoning Board of Appeals, and Land Use Department Staff was formed to revise the Brookfield Zoning Regulations, which govern the types of land uses and buildings permitted, and should reflect the community's land use goals-from protecting residential neighborhoods to promoting beneficial economic development in areas like the Federal Road corridor. The Town has contracted with Milone & MacBroom, Inc. to conduct the technical work relating to the zoning overhaul. Housing Rehabilitation Program 0% Interest Loans A Small Cities Grant - Town of Brookfield



Does your roof or plumbing leak? Does your heating system leave you cold? The Housing Rehabilitation Loan program can help you make these repairs with no out of pocket expenses.

The Town of Brookfield is now accepting applications for its Housing Rehabilitation Loan Program. Sponsored by HUD (Housing and Urban Development) and the Town of Brookfield, the program provides INTEREST FREE - DEFERRED PAYMENT HOME IMPROVEMENT LOANS to qualified low and moderate income residents. The loans are not due and payable until the home is sold.

Examples of eligible repairs are: roof and window replacement, lead paint removal, electrical & heating system upgrades, code corrections, failed septic systems and handicap accessibility.

Eligible applicants must 1) be up to date on property taxes; 2) have 10% equity in the home; and 3) be low or moderate income by HUD standards.

THE PROGRAM REQUIRES NO OUT OF POCKET EXPENSES.

On Monday, March 6, 2017 at 7:30 PM, the Brookfield Museum and Historical Society will

host a PowerPoint presentation by Dr. Raymond Sullivan, Director of Public Health for the Town of Brookfield. The presentation will cover two famous patriots who made significant contributions leading to the success of the War of Independence in the early stages of the American Revolution. Sullivan will highlight the significant actions of both John Adams and Dr. Joseph Warren in rallying the colonists towards armed revolt.



Sullivan, a retired cancer surgeon, is an ardent student of New England History. He is a member of the Massachusetts Historical Society and has taught New England history at the Waterbury Campus of the University of Connecticut. He has published "Contentment: A Novel Of New England Birth". His second work "Softness and Sensibility: A Biography of Abigail "Nabby" Adams Smith America's First Princess" is currently being edited.
