BOARD OF SELECTMEN PUBLIC HEARINGS

Prior to the May 1 meeting the BOS will conduct a Public Hearing at 7:15 p.m. in Meeting Room 133 to hear public comment on an amendment to Ordinance Section 127-7. The

amendment would enable the Wetlands Enforcement Officer to make the determination of and approve a permit transfer as an agent duty and establish a \$25 fee for the transfer. The BOS will also hear public comment for a proposed Ordinance (new section 127-5) for Land Use Agency Fees to be determined and set by Land Use Boards and Commissions (Inland-Wetlands, Planning, Zoning and Zoning Board of Appeals).

ANNUAL TOWN MEETING AND FY 2017-2018 BUDGET REFERENDUM

Our Annual Town Meeting for FY 2017/2018 Town and School Operating and Capital Budget is scheduled for Tuesday, May 2, at 7 p.m. in the Brookfield High School Auditorium. The Board of Finance's final budget recommendation will be reviewed. The Budget Referendum recommended date is Tuesday, May 16, to be set at the Annual Town Meeting.

CHARTER REVISION COMMISSION

At the Board of Selectmen Meeting on May 1, a date for a Public Hearing on the Charter Revision Commission Draft Report will be proposed for Thursday, May 11 at 7 p.m. in Meeting Room 133. The 12-page CRC Draft Report and Recommendations is located in the Town Clerk's office and the Town website.

Liens on 2015 Grand List Real Estate

Liens will be placed on all unpaid Real Estate parcels at the beginning of the month. Please pay any outstanding balances to avoid the lien and fees.

Collection Agency

Delinquent taxes will be sent to Tax Serv, our collection agency, for collection. This will include the Grand List years of 2013 and 2014. All previous years are already with the Collection Agency.

July 2017 Billing

In preparation of the next billing cycle if your Real Estate taxes are escrowed, the bank should request your Real Estate bill. If you have changed banks or have paid off your mortgage, please contact the Tax Office to let us know where the bill should be sent.

Tax Assessor News

Town Elderly Tax Relief Benefit requirements for the 2016 GRAND LIST (2017/2018 tax bills) are as follows:

- 1. An applicant or their spouse was 65 years of age or older as of December 31, 2016.
- 2. A person has resided and paid real estate taxes on their Brookfield residence for a period of five years immediately prior to application for tax credit. Applicants must be current on their tax payments.
- 3. The net assessment of an applicant's property shall not exceed the median assessment of \$236,860 for the current 2016 Grand List year.
- 4. A property must be the legal residence of an applicant and occupied by the applicant more than 183 days of each calendar year.
- 5. Applicant income must not exceed \$49,280 unmarried and \$60,060 married. "Income" is defined as total income from the 2016 IRS Form 1040, in addition to Social Security and tax-exempt income. If an applicant is not filing an income tax return, copies of all income statements for 2016 must be submitted with an application.
- 6. Applicant must be the record owner of a property as of October 1, 2016.
- 7. Applications must be filed between February 1 and May 15 annually.

Town Additional Veteran Exemption requirements for the 2017 GRAND LIST (2018/2019 tax bills) are as follows:

- 1. Must have form DD214 Discharge filed with the Town Clerk's Office by September 30 of the Grand List year in which a veteran is applying.
- 2. Veteran must have served during an eligible war period and have been Honorably Discharged.

- 3. Income must not exceed \$52,700 unmarried and \$58,900 married for calendar year 2016. "Income" is defined as total income from the 2016 IRS form 1040 PLUS Social Security and tax exempt income.
- 4. Filing period is from February 1 to September 30.

State Elderly Tax Relief Benefit and State Additional Veteran Exemption requirements are as follows:

- 1. Applicants must be the owners and legal residents of Real Property as of October 1 of the filing year. Elderly Tax Relief applicants or their spouse had to be age 65 as of December 31, 2016. There is no age limit for the State Additional Veteran Exemption.
- 2. Income cannot exceed \$35,200 unmarried and \$42,900 married. "Income" is defined as total income from the 2016 IRS form 1040, in addition to Social Security and tax exempt income. If an applicant is not filing an income tax return, copies of all income statements for 2016 must be submitted with an application.

The State of CT DOT has approved our bid package and the project was advertised in the News-Times, the Town's <u>website</u> and the State Contracting portal starting on April 12. Bid packages are also available in the Land Use Office. There was a mandatory pre-bid meeting for interested contractors on April 25. Bids are due on May 12. this riveting production.



BROOKFIELD MUSEUM LECTURE AND BOOK SIGNING By Ret. Marine Lt. Col MICHAEL ZACCHEA

On Monday evening, May 1, 2017, at 7:30 PM, the Brookfield Historical Society will sponsor a book signing and multimedia presentation by retired Brookfield Marine Lt. Col. Michael Zacchea. He recently published the book *The Ragged Edge: A US Marine's Account of Leading the Iraqi Army Fifth Battalion* He will discuss the work as well as provide insight into the current conditions and challenges that face the US Military in the war against ISIS and International terrorism in the Middle East. The program will take place at the Brookfield Museum located at 165 Whisconier Road (Intersection of Routes 25 and 133) in Brookfield Center.

Zacchea is the Director and founder of UConn's Entrepreneur Bootcamp for Veterans with Disabilities. While on active duty he arrived in Iraq in mid-March, 2004 and was part of a combined multinational transition team serving as a senior advisor to and Iraqi battalion. He was among the first American military advisors to organize, train and lead former Iraqi's, soldiers, once loyal to Saddam Hussein, into combat against foreign insurgents and al-Qaida forces. He was seriously wounded in the second battle to overtake the rebel stronghold of Fallujah in November-December 2004 and subsequently received a Purple Heart and 2 Bronze Star for Valor as well as being the only American soldier ever to receive from the President of Iraq, the Order of the Lion of Babylon valor award.

BROOKFIELD MUSEUM WORLD WAR I EXHIBIT THE YANKS ARE COMING Opens Saturday May 13 Noon to 4 P. M.

The Brookfield Museum and Historical Society will host its Summer Exhibit The Yanks Are Coming to commemorate the 100th Anniversary of America's participation in World War I. The Exhibit opens on Saturday, May 13, 2107 and will continue each Saturday from Noon to 4 P.M. until further notice. It will also be open Sunday May 28th in conjunction with the Brookfield Memorial Day Parade. The Museum is located at the intersection of Rts. 25 and 133 in Brookfield Center. Complimentary refreshments will be served on opening day. The exhibit will include a huge display of original WWI artifacts to include Uniforms, field gear, posters, photographs, medals, insignias, weaponry, helmets, and more. In addition a special section will feature Brookfield on the Warfront and the Homefront during the war. Images of WWI veterans whose descendants live in Brookfield can be seen. Graphics will explain the conflict, its causes and long term effects, the American Expeditionary Force and new advancements in weaponry.
