Affordable Housing

We have been granted a four-year moratorium on affordable housing, but there are still four applications that were submitted before the moratorium took effect. We are going to fight these proposed projects because they are too dense for our residential neighborhoods and have significant shortcomings in providing safety and health.

I urge you to attend the Inland Wetland, Planning and Zoning board meetings to understand what these out-oftown developers want to build. Your support in opposing

these projects is needed if we are to be successful in blocking or scaling them back.

State Budget Cuts

We do not have a budget from the State, and Gov. Malloy has proposed cutting most of the grants we receive. We do not know the final State budget, so it is prudent to plan for the worst outcome. Therefore, I have ordered a hiring freeze, put a hold on all Capital projects we pay for with cash, and am working with each department to determine what expenses we can delay. The Board of Selectmen has asked the Board of Education to review its budget and report how it can help in these uncertain times. I have been working directly with John Barile, Superintendent of Schools.

Streetscape in Downtown

We have started to put down the sidewalks, which look great. The project is still on schedule and under budget. Please see the town <u>website</u> for pictures of our progress. Phase II design is underway, and we should have preliminary design drawings in the next six weeks.

Ad Hoc Committees

We have recruited a number of volunteers to fill both the Facilities Committee and the Senior Tax Abatement Committee. The Facilities Committee has met once; we will be convening the first meeting of the Senior Tax Abatement Committee shortly. The Facilities Committee is reviewing all town properties to help our infrastructure planning. We're considering renovating our school buildings, expanding our police station and building a library. We need a comprehensive plan that ensures we don't lose playing fields while we proceed with new building projects. The Senior Tax

Abatement Committee will be doing an in-depth study of the tax incentives we offer our senior residents to determine if they are fair and if they are in line with other area towns.

Brookfield Town Center Streetscape Construction

Construction of streetscape Phase 1 in the Brookfield Town Center has been moving right along. Five new utility poles were set on Federal Road south of the intersection. Eversource is on schedule to move wires onto the new poles by the end of August. Concrete sidewalks, driveway aprons and granite curbing are being installed daily, and pedestrian lighting and sidewalk light pole bases are being set. Tree trimming at the inside corner on Whisconier Road between the Craft Center buildings has been completed to improve the vehicle line of sight.

Tax Assessor

Attention all Business Owners:

If you are new to town and haven't registered your business, please stop by our office. If you recently closed your business in town, you will need a letter of dissolution from the state, an affidavit of business closing/moving/sold (page one of the personal property form), and a copy of your release of trade name certificate from the Town Clerk. If you have any questions, please call the Assessor's office at 203-775-7302.

Attention all Veterans:

There are two income-driven tax credit programs available. The state income limits are \$35,200 for single, \$42,900 for married. The town income limits are \$52,700 for

single and \$58,900 for married. If you think you meet the income criteria and have not applied recently, please stop in our office with your full tax return and all 1099's. Applications are available on the town <u>website</u> under the assessor tab or at our office. Applicants must apply by October 1, 2017.

If you are currently serving in any of the military branches, there is an active duty exemption for one of your motor vehicles, and a basic veterans exemption on your home or additional vehicle. The form is on the <u>website</u> under assessor and available in our office. Please return the form with a copy of your LES statement for October 1, 2016 for any vehicle on the 2016 grand list or a LES statement for October 1, 2017 for the future 2017 grand list along with a copy of your ID.

If you are new to Brookfield or recently discharged from any branch of the service, please file your original DD-214 paper with the Town Clerk to be eligible for a veteran exemption. The filing deadline is September 30, 2017 for the 2017 grand list. You only have to file the DD-214 paper once in the town you are living in.

September is National Preparedness Month Disasters don't plan - BUT YOU CAN!

As we watch the devastation caused by Hurricane Harvey and anticipate winter, September is a good time to plan for an emergency in town. Emergency Planning Guides are available on the Brookfield Health Department display in the lobby of Town Hall. These measures can ease the burden on individuals and businesses:

- First and Foremost Make a family emergency communication plan and include your pets.
- Identify an out-of-town emergency contact to coordinate information with family/friends.
- Identify a common location outside the home where family members can meet if a disaster strikes the home.
- Check on neighbors.
- Keep an emergency kit wherever you spend time: home, car, work etc.
- Download the FEMA App and set up local alerts.
- Listen to local officials by radio, TV, or social media and take action.
- Practice your preparedness plans with a drill or exercise.
- Take a first aid class so you can help until first responders arrive.
- Sign up yourself and your family for emergency notifications on <u>CTAlert.gov</u>.
- Log on to <u>FEMA.gov</u> for more helpful information on Planning for an Emergency

Brookfield Museum Hosts Presentation on Revolutionary War Battle of Long Island

On Monday evening September 11, 2017 at 7:30 PM the Brookfield Historical Society will host a multi-media presentation in the Brookfield Museum located at 165 Whisconier Road (Intersection of Routes 25 and 133) in Brookfield Center. The speaker,



Joseph Cerreto, will feature a program on the Revolutionary War Battle of Long Island. It was fought on August 27, 1776 and was the first major battle to take place after the United States declared its independence on July 4, 1776. It was a victory for the British Army and the beginning of a successful campaign that gave them control of the strategically important city of New York. In terms of troop deployment and fighting, it was the largest battle of the entire war.

Cerreto, is a reenactor in the 2nd NY Regiment, a recreated Revolutionary War Continental Line unit, and part of the Brigade of the American Revolution. The 2nd was an actual combat regiment, formed in 1775. Elements of the regiment took part in most of the major combat actions in the Revolutionary War. He will appear in his period Regimental Uniform complete with musket and field equipment.

Admission is free and following the program complimentary refreshments will be available.
