  - Grant to match up to, not to exceed, 15% or \$450,000.00 of the cost in the total amount of \$3.6 Million
    - Previously voted on and approved December 9, 2020 however the total amount (\$3.6M) was not included in the motion this is for clarification/correction in the BOF minutes

M. Mulvaney adopted First Selectman S. Dunn's motion, seconded by Vice Chairman E. Koch, for the Board of Finance's approval of a LoTCIP Grant for a match up to, not to exceed, 15% or \$450,000 of the cost of the project in the total amount of \$3.6 Million. Motion carries unanimously.
