

BROOKFIELD BOARD OF FINANCE Special Meeting Minutes Friday, March 17, 2023 7:00pm Town Hall Room 209

<u>CALL TO ORDER</u>: Vice Chairman E. Koch called the meeting to order at 7:00pm; beginning with the Pledge of Allegiance.

NEW BUSINESS:

• 2023-2024 Town of Brookfield Budget Discussion:

First Selectwoman T. Carr and IT Director D. Secore left the meeting at 7:38pm.

<u>Board of Finance Budget Deliberation</u> – After budget deliberation, Vice Chairman E. Koch, made a motion seconded by R. Roudenis, that the Board of Finance approve and recommend to a Town Meeting and Referendum, the following operating budget for Fiscal Year 2023-24:

Town Operations	\$ 21,938,307
School Operations	\$ 50,510,562
Debt Service	\$ 7,703,957
Capital Projects	\$ 2,287,218
Total	\$82,440,044

as outlined and described in the Operating Budget being submitted to the Town Clerk. This budget represents an increase of 3.98% over the mill rate over the prior fiscal year and anticipate a mill rate of 26.91 for fiscal year 2023-24. Motion carries 5-0.

A motion was made by Vice Chairman E. Koch, seconded by Secretary B. Ruocco, that the Board of Finance approve and recommend to a Town Meeting and Referendum, an amount not to exceed \$8,532,745 for the Capital Budgets for Fiscal Year 2023-24 as outlined and described in the Capital Budget being submitted to the Town Clerk. And to approve financing in an amount not to exceed these amounts with the issuance of bonds and/or temporary notes in accordance with the standard bonding and borrowing resolution for said appropriation not to exceed \$1,000,000.
