

## BROOKFIELD BOARD OF FINANCE Special Meeting Minutes Thursday March 18, 2021 7:00pm Virtual Meeting

## **NEW BUSINESS:**

• 2021-2022 Town of Brookfield Budget Discussion:

A motion was made by Chairman G. Rooney, seconded by D. Devorsetz, to call a 10 minute recess at 8:42pm. Motion carries unanimously. Meeting convened back in session at 8:52pm

After discussion, Chairman G. Rooney, seconded by Vice Chairman E. Koch, moved to approve, and to recommend approval to a Town Meeting and Referendum a total budget of \$74,918,791 for the fiscal year 2021-22 comprised of \$19,920,362 for town operations, \$46,816,379 for school operations, \$5,826,802 for debt service and \$2,355,248 for capital projects as outlined and described in the budget being submitted to the Town Clerk. This budget represents an increase of 1.52% in the mill rate over the prior fiscal year and brings the mill rate from 29.65 for fiscal year 2020-21 to 30.10 for fiscal year 2021-22. Motion carries unanimously.

Chairman G. Rooney, seconded by Vice Chairman E. Koch, moved to approve, and to recommend the approval of a Town Meeting and Referendum \$4,770,379 to finance the costs of the 2021-22 Capital Improvements Project as described in the Capital Projects Plan and to approve the issuance of bonds and temporary notes to finance said appropriations in accordance with the standard bonding and borrowing resolution for said appropriations. Motion carries unanimously.
