A motion was made by Chairman G. Rooney, seconded by M. Cappiello, to move New Business Agenda item, Radio Communications Systems Upgrade Project up next for discussion. Motion carries 5-0.

<u>Radio Communications Systems Upgrade Project</u> – Chief J. Puglisi gave the Board of Finance a presentation on the Radio Communications System Upgrade Project. After discussion, this agenda was tabled and will be discussed at a BOF Special Meeting on Wednesday, April 19, 2023.

**REPORT OF THE FINANCE DIRECTOR:** Town Finance Director M. Marien gave the Board of Finance an overview of Revenue and Expenditures for the month of March 2023. She also reported on Capital Projects Status. Town Finance Director M. Marien requested to add to next month's agenda Selection of Auditor.

- <u>Salary Study RFP</u> A motion was made by Chairman G. Rooney, seconded by Vice Chairman E. Koch, to expedite the Salary Study RFP. Motion carries 5-0.
- By-Laws Board of Finance Review -

A motion was made by Chairman G. Rooney, seconded by D. Devorsetz, to approve inter-department transfers in the amount of \$56,000 as shown on the attached budget vs. actual. Motion carries 5-0.

A motion was made by Chairman G. Rooney, seconded by Secretary B. Ruocco, to transfer the funds netting to \$141,326 between the specific YE 2022 bonded projects from the funds previously closed YE 2022 bonded capital not in accordance with the error that was seen on the board, but in accordance with the actual number which is \$141,326. Motion carries 5-0.

A motion was made by Chairman G. Rooney, seconded by M. Cappiello, to transfer funds netting to \$7,546 from the fund balance not yet allocated to projects to the projects noted on the Summary of Financial Reports. Motion carries 5-0.

• <u>By-Laws Board of Finance Review</u> - Vice Chairman E. Koch reviewed the proposed changes to the BOE Bylaws. The Board will vote on these changes at next month's meeting.
