NEW BUSINESS: BOE Vice Chairman, J. Greenstein provided a recap of the BHS Boys Locker Room Project and the Whisconier Middle School Wall.

• Board of Education request for additional funding for the Whisconier Middle School Wall

A motion was made by Chairman G. Rooney, seconded by R. Roudenis, that the Board of Finance approve an additional expenditure in the amount of \$68,500 over and above the bid amount of \$796,000 for the completion of the WMS Wall Refurbishment project to be funded from Capital Non-Recurring. Motion carries 4-0.

 Board of Education request for additional funding for the BHS Boys Locker Room Project

A motion was made by Chairman G. Rooney, seconded by R. Roudenis, that the Board of Finance approve the amount of \$117,176 for the BHS Boys Locker Room project which would be funded from the Bonded Capital of the Whisconier Middle School Electrical project. Motion fails 4-0.
