<u>APPROVAL OF MINUTES OF PREVIOUS MEETINGS</u>: A motion was made by Secretary B. Ruocco, seconded by R. Roudenis, to approve the BOF September 20, 2023 Special Meeting Minutes as presented.

- <u>By-Law Change and Vote</u> After discussion, a motion was made by Chairman G. Rooney, seconded by D. Devorsetz, to pass the Bylaws as revised per today's date; with one revision to change the date in the footnotes. Motion carries 6-0.
- <u>Transfers</u> A motion was made by Chairman G. Rooney, seconded by D. Devorsetz, to approve the Inter department transfers for year end 2023 as noted on the Budget vs. Actual expenditure report. Motion carries 6-0.

A motion was made by Chairman G. Rooney, seconded by Vice Chairman E. Koch, to approve the revenue transfers for year end 2023 as noted on the Budget vs. Actual revenue report. Motion carries 6-0.

A motion was made by Chairman G. Rooney, seconded by R. Roudenis, for the transfer of cash from the Cash capital to Bonded capital fund in the amount of \$51,230 as approved by the Board of Selectman. Motion carries 6-0.

A motion was made by Chairman G. Rooney, seconded by M. Cappiello, to approve the additional appropriations to these projects budgets funded by a transfer from the Capital Nonrecurring Fund as approved by the Board of Selectman. Motion carries 6-0.
