

BROOKFIELD BOARD OF FINANCE

Meeting Minutes Wednesday, December 13, 2023 7:00pm Room 209 Town Hall

<u>CALL TO ORDER</u>: (by First Selectman Steve Dunn) – First Selectman S. Dunn called the meeting to order at 7:04pm; beginning with the Pledge of Allegiance.

ELECTION OF OFFICERS: First Selectman S. Dunn began nominations for the position of Chairman. E. Koch nominated G. Rooney, seconded by D. Devorsetz. All members were in favor. First Selectman called for nominations for the position of Vice Chairman. M. Cappiello nominated E. Koch for Vice Chairman, seconded by B. Hoffman. All members were in favor. First Selectman S. Dunn called for nominations for the position of Secretary. D. Devorsetz nominated M. Cappiello for Secretary, seconded by E. Koch for the position of Secretary. All members were in favor.

PUBLIC COMMENT:

A motion was made by Chairman G. Rooney, seconded by Vice Chairman E. Koch, to move agenda items, under Old Business as follows; Police Outside Services Fund, STEAP Grant, and LOTCIP. Motion carries unanimously.

- Police Outside Services Fund: Discussion and possible motion thereon:
 A motion was made by Chairman G. Rooney, seconded by Secretary M. Cappiello, to approve the Police Outside Services Fund appropriation of \$220,000 for the purchase of a mobile operations vehicle as approved by the Board of Selectmen. Motion carries unanimously.
- STEAP Grant: Discussion and possible motion thereon:
 A motion, to approve the appropriation from the Capital Non-recurring fund balance, up to and not exceeding \$100,000 and to approve the scheduling of a town meeting for the approval of the entire expenditure of \$589,000 of which \$489,000 will be reimbursed by the STEAP grant.

• <u>LOTCIP- Streetscape Phase 7</u>: Discussion and possible motion thereon: A motion to approve an appropriation not to exceed \$109,000 for the design engineering costs contingent upon 100% reimbursement of approved agreement for a total project cost of \$1.7 million, submit the LOTCIP grant and to schedule a special town meeting.
