3. <u>NEW BUSINESS</u>

a. Plan to move forward with Brookfield Market Area Project

Brookfield Market – A plan is drawn, but costs are too high for the properties. A discussion in a joint session of the BOS and BOF was slated for June but is now put off until September or October when the climate for covering extra costs is more favorable. b. Plan to move forward with Dean Pocono Road

Dean/Pocono Road Area – The studies have been completed. Full details can be accessed from https://brookfieldwpca.org/projects/districts/dean-road-area/

A next step is to have a public hearing with owners, but when that might be scheduled is anybody's guess. With that done, a request for bond financing has to be made to the BOF for funds to do the project. The Still River is on the CT DEEP priority list for action in 2022. It is uncertain if that will translate to funding.

c. Plan to move forward with Candlewood Lake Project

Candlewood Lake Area – This is considerably more complex. The next step is to have a public hearing to present report findings. One was slated for the end of March, but the corona crisis deflected that. It is necessary to get with CT DEEP to gauge their thinking. We are hopeful to arrange a DEEP visit, which may be by Zoom. d. Plan to move forward with Facilities Plan Report
